Information Security

Elstree and Borehamwood Town Council has a duty to ensure the security of personal data. This is done through appropriate technical measures and appropriate policies. Copies of these policies can be requested.

We will only keep your data for the purpose for which it was collected and only for as long as is necessary, after which it will be deleted. (You may request the deletion of your data held by Elstree and Borehamwood Town Council at any time).
