1. APOLOGIES FOR ABSENCE

Apologies for absence were received for other business from Rev. L Collins (St Michael's Church).

2. NON DENOMINATIONAL ADDRESS BY LOCAL RELIGIOUS LEADER ON COVID-19 PANDEMIC AND EFFECTS ON THE COMMUNITY

Rev Tim Warr (All Saints Church) provided an inspiring and deeply moving account of the impact of the Covid-19 pandemic on the local community, highlighting how people had come to feel isolated or, as he put it, "locked out in lockdown." The importance of looking after one another was emphasised and the need to come together in times of difficulty. The Mayor and all present were grateful for Rev Warr's important words to the people of Elstree and Borehamwood.

3. MINUTES OF LAST ANNUAL PARISH MEETING

The minutes of the last Annual Parish Meeting of 4 March 2020 were confirmed as a true record by those present and the Mayor was authorised to sign them as a true record.

3 REPORT OF THE MAYOR OF ELSTREE AND BOREHAMWOOD

The Town Mayor, Cllr S Rubner, welcomed 40 Members of the Public to the meeting and set out the purpose of the Annual Parish Meeting (APM) as an opportunity for electors to have their say on anything they consider to be important to the people of Elstree and Borehamwood. He said:

"I particularly felt honoured to work with local charities providing essential services and supplies through lockdown – Gratitude and Goods for Good. It always amazes me how local volunteers step forward to meet the demands that are put on Elstree and Borehamwood. They work selflessly and their efforts should not go forgotten and unnoticed. I was also pleased to become a vaccination volunteer at various locations, including Allum Hall."

The Mayor also provided introductions to a number of virtual events including concerts as well as attending in person where this was possible (e.g. the opening of the cycle hub at the railway station).

The Mayor presented his report of his year in Office in the form of a video slideshow prepared with the assistance of and thanks to D Salter - Entertainments Officer. The video showed a compilation of the Mayoral Engagements and Council Events which Cllr Rubner, together with his wife, Gina, had attended.

5. YOUTH COUNCIL

Youth Councillor Alex Sneader was welcomed to the meeting and gave an informative and comprehensive report on the activities of the Youth Council during the course of the year together with the ambitions of the Youth Members going forwards. The Youth Council had continued to meet on a monthly basis via Zoom during the course of the pandemic. The Youth Council had attended the General Election count, laid wreaths on Armistice Day and assisted at the Christmas Concert at Allum Hall. They had conducted pre-Lockdown trips to King's Cross Station in London and a visit to the Houses of Parliament. Other activities included partnership working with First Impressions to maintain the planters around Elstree and Borehamwood Railway Station. The Youth Council looked forward to having a representative on the Town Council's Sustainable Transport Subcommittee to have a "real say" on the future of green transport in the local area. Communication, task management and leadership were among the skills that Youth Councillors had gained from being part of this important body representing the views of young people.
