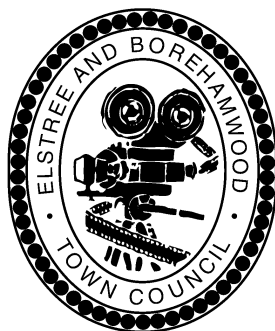


ELSTREE AND BOREHAMWOOD TOWN COUNCIL

12. APOLOGIES

13. DECARATIONS OF INTEREST

14. MINUTES

It was **RESOLVED** that:

the Minutes of the Annual Council Meeting held on 4 May 2021 be signed by the Mayor as a true record and adopted by the Council.

15. ANNUAL RETURN 2020/21

Cllr C Butchins asked for a record of thanks to be noted in the Minutes to Council Staff for helping to achieve a complimentary report from the Internal Auditor for the 2020/21 year.

- (iv) Section 1 of the Annual Governance Statement 2020/21 be approved and adopted for submission to the External Auditor before 30 June 2021;**
- (v) Section 2 of the Annual Governance Statement 2020/21 be approved and adopted for submission to the External Auditor before 30 June 2021;**
- (vi) The dates for the public rights period be agreed as 24 June – 6 August 2021 for inspection of AGAR and accounts 2020/21;**
- (vii) Auditing Solutions Ltd be appointed as Internal Auditor to the Council for the municipal year 2021/22; and**
- (viii) Entertainments Committee be asked to review the production costs of the Town Crier magazine in order to assess value for money and to consider further the option of producing the newsletter in online format only.**

16. OUTSIDE BODIES

Fairway Hall

It was noted that at its meeting on 8 July 2020, the General Management Committee would consider options for further action in relation to Fairway Hall floor in light of an independent report commissioned by the Town Council showing defects in the work carried out in August 2020 to replace the flooring.

It was reported that at the time of the meeting, Fairway Hall was booked for hours in the period between 1 April 2021 and 3 October 2021 as follows:

Members noted regular usage by MENCAP four times per week, a Baby Sensory Group on Tuesdays (5-hour booking) and the return of the Thursday Yoga class.

Elstree & Borehamwood Museum Group

Cllr A Collins reported that the Museum remained closed with a static display at 96 Shenley Road in the interim period. The Facebook page and website blog were active. The Council thanked the Museum staff and many volunteers for their continued efforts during the pandemic and noted that all involved in the Museum remained optimistic about better times to come.

Elstree, Borehamwood and District Community Association

Cllr Mrs S Parnell reported that it had been a challenging 12 months for Allum Manor. On 18 June 2021, a wedding was held with 30 guests in line with Covid regulations at that time. Events to be held later in the year included a Star Wars Family Fun Day, Aldenham Bus Spectacular and the NSPCC Christmas Party). The programme of internal decoration continued at the Manor House (new flooring and blinds in most rooms) with the aim of redecorating the external fabric in the coming months. The Hall continued to be used as a vaccination centre and by May over 50,000 doses had been given to over 30,000 patients. The Council wished to express thanks to the Allum Hall staff for helping to keep the traffic running smoothly whilst it was being used for this purpose.

Hertsmere MENCAP

Cllr V Eni reported that MENCAP was meeting four times per week at Fairway Hall with plans to invite visits from the Fire and Rescue Services, Hertfordshire Constabulary and Metro Bank.

Aldenham Country Park

Cllr P Strack reported that ParkRun would not resume at the reservoir until 24 July 2021 (but would be included in the Civic Festival on Saturday 31 July 2021 at 9.00am – registration could take place at www.parkrun.org.uk/aldenham).

It was noted that the "footpath issue" was moving forwards with the likelihood that it would be registered as a Public Right of Way. It was further noted that the Town Council had put in an application to register the reservoir as an Asset of Community Value (ACV) with Hertsmere Borough Council.

First Impressions Group

Cllr Mrs S Parnell reported that the last project board meeting had taken place on 12 March 2021. An update was provided on the Passenger Benefit Fund (£80,000 to pay for station improvements as compensation for the disruption caused by the introduction of a new train timetable in 2018). Members expressed disappointment at the slow progress and seemingly high cost of the improvements (planting, seating and an electronic information kiosk). On a positive note, the cycle hub opened in 2020 was seen to be a huge improvement at the station for passengers. It was noted that Cllrs Parnell and Collins would report back to the Council on progress. Mr B Redman is the principal organiser of the group - Since 2008 this multi-agency group had been using film and TV images in public spaces to create a more welcoming "First Impression" of Elstree & Borehamwood.

21. PUBLIC PARTICIPATION – QUESTION TIME

A motion was proposed by Cllr R Butler and seconded by Cllr J Newmark to suspend standing orders in order for Members to be able to vote on a motion brought to the attention of the Council two days prior to the Council meeting by Cllr Butler. Voting 6 in favour and 7 against, the motion to suspend standing orders fell.

Members discussed the merits of considering the following motion before agreeing not to suspend standing orders at this meeting:

“NHS GP Provision in Borehamwood

Council notes growing local disquiet about the lack of GP provision in Borehamwood. Council recognises the huge amount of development and new homes and notes the further growth mandated by Government targets that will be delivered after publication of Hertsmere Borough Council’s new Local Plan. Council believes that this growth creates the need for better infrastructure to accommodate it. Council specifically notes the need for new, additional GP provision in South Borehamwood to cover the Hillside and Kenilworth Wards. Council therefore resolves to use its General Power of Competence to support, and if appropriate help fund, any initiatives to campaign for and deliver this provision. Council further resolves to write to the local MP, Borough and County Council Leaders and the Chair of Herts Valley CCG calling for urgent multi-agency action to deliver this provision.”
