# 23. APOLOGIES

### 24. DECARATIONS OF INTEREST

# 25. MOTIONS SUBMITTED BY MEMBERS

The Town Mayor provided details of how the Extraordinary Council Meeting had been called and read out the motion entitled "NHS GP Provision in Borehamwood" proposed by Cllr A Collins, Cllr J Newmark, Cllr R Butler and Cllr R Challice.

It was noted that suspension of Standing Orders did not entail that the Council could make resolutions that were outside of the statutory obligations contained in the Local Government Act 1972 and elsewhere (such resolutions would not be legally enforceable).

# It was RESOLVED that:

(i) the following motion be adopted:

Council notes growing local disquiet about the lack of GP provision in Borehamwood. Council recognises the huge amount of development and new homes and notes the further growth mandated by Government targets that will be delivered after publication of Hertsmere Borough Council's new Local Plan. Council believes that this growth creates the need for better infrastructure to accommodate it. Council specifically notes the need for new, additional GP provision in South Borehamwood to cover the Hillside and Kenilworth Wards. Council therefore resolves to use its General Power of Competence to support, and if appropriate help fund, any initiatives to campaign for and deliver this provision. Council further resolves to write to the local MP, Borough and County Council Leaders and the Chair of Herts Valley CCG calling for urgent multi-agency action to deliver this provision; and

- (ii) Standing Orders be suspended (in order to make Resolution 25. (iii) below); and
- (iii) none of the provisions in Resolution 25. (i) above be reversed for a period of 24 months.

### **26.** PUBLIC PARTICIPATION – QUESTION TIME

### NHS GP Provision in Borehamwood

Representations were made by a Member of the Public in support of the Resolution at Minute 25(i) above – citing a need for additional GP provision and patient dissatisfaction with waiting times at GP surgeries locally.
