## 41. PLANNING APPLICATIONS - HERTSMERE BOROUGH COUNCIL

A total of 35 applications received from the Borough Council were examined, on 30 of which the Committee had no objections to make, subject to the views of neighbours. The ActingClerk was requested to make the following observations on the 5 remaining applications:

TP/10/2044 - 26 Lullington Garth, Borehamwood WD6 2HE Proposal:-Two storey side/rear extension Observation:- The Committee had concerns about loss of parking and considered that the proposal constituted overdevelopment

TP/10/2046 - Land rear of 32 Grantham Green, Borehamwood Proposal:- Erection of a pair of 3 bedroom semi-detached two storey houses with parking (Revised Application) Observation:- The Committee considered the proposal to be overdevelopment

TP/10/2095- Land at Allum Lane, Elstree WD6 3PJ Proposal:- Residential development of 76 dwellings comprising 73 apartments and 3 houses, car parking, cycle storage, landscaping and waste/recycling areas. Observation:- The Committee had concerns about access

TP/10/2108 - 1-12 Deacons Heights, Barnet Lane, Elstree Proposal:- Installation of two sets of entrance gates, one each for no 1- 8 and no 9-12 Deacons Heights following refusal under TP/09/1103 Observation:- The Committee had concerns about the aesthetic appearance and the likely effect of the proposal on the street scene ELSTREE AND BOREHAMWOOD TOWN COUNCIL
