#### 49. PLANNING APPLICATIONS - HERTSMERE BOROUGH COUNCIL

A total of 14 applications received from the Borough Council were examined, on 9 of which the Committee had no objections to make, subject to the views of neighbours. The Acting Clerk was requested to make the following observations on the 5 remaining applications:

#### TP/10/2153 - 15 Barham Ave, Elstree WD6 3PW

Proposal:- Two storey front, side and rear extension with addition of accommodation in loft space with associated alterations to roof to include increased roof height and addition of dormer windows to front, side and rear.

Observation:- The Committee considered that the proposal constituted overdevelopment but also felt insufficient information had been provided

#### TP/10/2263 - 109A Theobald Street, Borehamwood WD6 4PT

Proposal - Raising of garage and front canopy flat roof and converting garage into habitable room Observation - The Committee noted that there were two parking spaces but were concerned about the loss of off street parking

#### TP/10/2227 - 39 Pinewood Close, Borehamwood, WD6 5NU

Proposal:- Side extension and garage conversion (Certificate of Lawful Development – Existing) Observation:- The Committee had concerns about loss of parking.

Proposal - Erection of single storey front extension; two storey side extension; single storey side/rear extension; single storey rear extension

Observation:- The Committee had concerns about the percentage increase in size of the dwelling
