Cllr Mrs S Parnell in the Chair (Mayor)

1. ELECTION OF TOWN MAYOR

(i) Election of Mayor for 2023/24

Cllr Mrs S Parnell was in the Chair in her capacity as outgoing Mayor until the Town Mayor was elected. She read out the Equalities Act policy.

It was proposed by Cllr R Butler, and seconded by Cllr D Ozarow, that Cllr R Challice be elected Mayor for the ensuing Municipal Year.

Cllr R Butler said it had been an honour to work with Cllr Parnell as Mayor and also thanked former Cllr Pat Strack for all her work for the Town Council over the years.

Cllr Butler nominated Cllr Rebecca Challice as Town Mayor, citing her contribution to the Town since being elected in January 2018, following being a Member of the London Borough of Barnet since the age of 19. She would be the youngest Town Mayor.

Cllr Dan Ozarow seconded the nomination, mentioning the contribution made by Cllr Challice to the Transport Forum, her work on the environment, climate change and support of children in secondary education – and also noting that Cllr Newmark would be her Consort. Cllr Parnell spoke in support of the nomination.

It was RESOLVED that:

Cllr Rebecca Challice was elected unopposed as Town Mayor for the ensuing Municipal Year 2023/24 and read out and signed the Declaration of Acceptance.

(ii) Incoming Mayor's Announcement

In her Incoming Mayor's Announcement Cllr Challice thanked her family and friends for their support and stressed the importance of collaboration with the Borough Council. Cllr Challice thanked the outgoing Mayor for her support and for her work on International Affairs. Cllr Challice thanked the Acting Clerk for her support during a particularly difficult period, also thanking the support of members of staff. She praised the Youth Council for their forward-looking attitude and hoped to bring economic improvement to the Town.

(iii) Outgoing Mayor's Announcement

In her Outgoing Mayor's Announcement, Cllr Parnell said that, in her 21 years on the Town Council, she had always taken on responsibilities with enthusiasm. She stressed the importance of working together and putting politics aside in local affairs. She wished Cllr Challice a successful year as Mayor without any disrespectful attitudes. Cllr Parnell thanked all the staff at the Town Council who had worked so hard, especially since February and throughout her mayoralty and all the special

events that had taken place, mentioning all by name, especially the Acting Clerk, Entertainments Officer and her Secretary.

2. ELECTION OF DEPUTY TOWN MAYOR

It was proposed by Cllr J Newmark, and seconded by Cllr P Kaza, that Cllr A B Collins be elected Deputy Mayor for the ensuing Municipal Year.

Cllr Jeremy Newmark was proud to nominate Cllr Alpha Collins as Deputy Town Mayor. He said Cllr Collins was "the people's Councillor" well known around the Town and very supportive of helping in the current cost of living crisis and post-pandemic recovery.

Having a female Jewish Mayor and African Deputy Mayor showed the diversity of the Town Council.

Cllr Prabhakar Kaza seconded the nomination and said that Cllr Collins was a good friend and colleague – very supportive of the local community.

It was RESOLVED that: Cllr Alpha Collins was elected unopposed as Deputy Town Mayor for the ensuing Municipal Year 2023/24 and read out and signed the Declaration of Acceptance.

- (i) authorisation be hereby made for Elstree and Borehamwood Town Council to be entitled to exercise the General Power of Competence contained in the Localism Act 2011 in the 2023/24 municipal year;
- (ii) it be hereby affirmed that Elstree and Borehamwood Town Council met the statutory criteria set out in the Parish Councils (General Power of Competence) (Prescribed Conditions) Order 2012 in order to invoke (i) above; and
- (iii) the eligibility of the General Power of Competence be next reaffirmed, subject to the approval of Members, at the Annual Council Meeting in May 2024.
